#### PJM announces delays to base residual auctions

On March 27, PJM Interconnection, LLC (PJM) announced that its Board of Managers has directed it to seek Federal Energy Regulatory Commission (FERC) approval to delay all upcoming reliability pricing model (RPM) base residual auctions (BRAs) and incremental auctions (IAs) as necessary, including the auction for the 2025/2026 delivery year (June 1-May 31) currently scheduled to occur in June.

PJM's board points to the ongoing stakeholder effort that could result in reforms to the capacity construct as the reason to delay the currently scheduled BRAs and IAs. PJM's board "determined that PJM should postpone executing any further auctions under the current rules until we go through the stakeholder process and file resulting rule change proposals with FERC."

At present, PJM has not submitted its filing to FERC, which should include the delayed schedule. AMP anticipates a future *Update* article on this topic.

### MISO announces delays to planning resource auction for delivery year 2023/24

On March 17, FERC issued an order to Midcontinent Independent System Operator, Inc. (MISO), establishing a show cause proceeding (Docket No. EL23-46-000) regarding seasonal accredited capacity (SAC) ratios for certain resources. FERC found that MISO was violating its tariff because it had failed to update its system-wide Unforced Capacity (UCAP)/Intermediate Seasonal Accredited Capacity (ISAC) ratio for the 2023/24 Planning Resource Auction despite having updated ISAC values for certain resources. Accordingly, FERC ordered MISO to either update the ratio that it uses to gauge anticipated supply or explain why it should not have to.

MISO reported that a software error counted previously excused generation outages against capacity accreditation, resulting in smaller capacity values than expected. MISO explained that it does not have time to implement the fixes necessary to its capacity model before it conducts the 2023/24 planning resource auction.

MISO now anticipates publishing auction results in mid-May, about a month behind schedule. The four seasonal auctions that were to be conducted concurrently in early April would have been the first to use a seasonal capacity framework.

### FirstEnergy Ohio March retail auction produces higher prices starting June 2023

The third of three auctions for FirstEnergy Ohio — encompassing OhioEdison, ToledoEdison and The Cleveland Electric Illuminating Company (CEI) — to purchase 34 percent of their retail load starting in June 2023 was completed on March 20. The auction cleared at a price of \$83.75/megawatt hour (MWh) or 8.4 cents/kilowatt hour (kWh) with five suppliers winning the bids.

The first auction representing 33 percent of their retail load starting in June 2023 had cleared at a price of \$122.30/MWh or 12.2 cents/kWh, and the second auction representing 33 percent of their retail load had cleared at a price of \$97.70/MWh or 9.8 cents/kWh. Combining the results from the three auctions produces a weighted average price of \$101.08/MWh or 10.1 cents/kWh. This price compares to the average price that FirstEnergy Ohio paid for the current June 2022-May 2023 planning year of \$53.62/MWh or 5.4 cents/kWh, representing an increase of 4.7 cents/kWh.

Assuming all other costs remain unchanged, total residential rates would be expected to change as follows:

- OhioEdison customers would see their current total residential rate of around 13.3 cents/kWh increase to about 18.0 cents/kWh, representing a 35 percent increase.
- ToledoEdison customers would see their current total residential rate of approximately 13.7 cents/kWh increase to roughly 18.4 cents/kWh, representing a 34 percent increase.
- CEI customers would see their current total residential rate near 13.5 cents/kWh increase to the order of 18.2 cents/kWh, representing a 35 percent increase.

#### **Energy market update**

The May 2023 natural gas contract debuted yesterday as the prompt month and decreased \$0.080/MMBtu to close at \$2.104 yesterday. The EIA reported a withdrawal of 47 Bcf for the week ending March 24, and was less than market expectations of 54 Bcf. Last year was an injection of 15 Bcf and the five-year average was -17 Bcf. Storage is now 1,853 Bcf, 31.3 percent above a year ago and 21 percent above the five-year average.

On-peak power prices for 2024 at AD Hub closed yesterday at \$45.27/MWh, which was \$7.03/MWh lower for the week.

### **AFEC** weekly update

The AMP Fremont Energy Center (AFEC) was in 2x1 configuration for the week. The plant cycled offline overnight last Saturday based on PJM economics. Duct firing operated for 49 hours this week. For the week, the plant generated at a 76.6 percent capacity factor, based on 675megawatt (MW) rating.

#### Belleville and Meldahl hydroelectric plants receive Low-Impact Certification

The Low Impact Hydropower Institute (LIHI) has certified the Belleville and Meldahl hydroelectric plants through its Low Impact Certification program. This is a voluntary program designed to recognize hydropower projects that minimize their impact on the environment.

The 10-year certification can increase the value of the associated renewable energy certificates in state renewable portfolio standards programs, and Green-e Energy, the nation's leading voluntary green power certification program.

#### EPA issues final ozone federal implementation plan

On March 15, 2023, the United States Environmental Protection Agency (EPA) finalized the Good Neighbor Rule (Rule) under the Clean Air Act and expanded the existing Cross State Air Pollution Rule trading program. The Rule seeks to further reduce nitrogen oxide (NOx) emissions from power plants and industrial sources (like cement kilns and glass furnaces) that contribute to downwind states' inability to attain or maintain compliance with EPA's 2015 Ozone National Ambient Air Quality Standards. Opponents have already expressed concerns that the rule will accelerate retirements of fossil generation, negatively impacting the reliability and affordability of power.

AMP's initial review of the Rule indicates that both AFEC and Prairie State Energy Campus have been allocated sufficient seasonal NOx allowances, and due to recent AMP actions, previously subject AMP and JV2 combustion turbines are no longer required to purchase and surrender NOx allowances.

#### Watch out for Silicon Valley Bank scams
