#### **Energy market update**

The August 2023 natural gas contract increased \$0.033/MMBtu to close at \$2.701 yesterday. The EIA reported an injection of 76 Bcf for the week ending June 23, which was below market expectations of 83 Bcf. Last year was an injection of 81 Bcf and the five-year average was +80 Bcf. Storage is now 2,805 Bcf, 25.3 percent above a year ago and 14.6 percent above the five-year average.

On-peak power prices for 2024 at AD Hub closed yesterday at \$49.25/MWh, which was \$0.70/MWh lower for the week.

### Understanding ransomware threat actors: LockBit

In 2022, LockBit was the most deployed ransomware variant across the world and continues to be prolific in 2023. Since January 2020, affiliates using LockBit have attacked organizations of varying sizes across an array of critical infrastructure sectors, including financial services, food and agriculture, education, energy, government and emergency services, healthcare, manufacturing and transportation.

LockBit ransomware operation functions as a ransomware-as-a-service (RaaS) model where affiliates are recruited to conduct ransomware attacks using LockBit ransomware tools and infrastructure. Due to the large number of unconnected affiliates in the operation, LockBit ransomware attacks vary significantly in observed tactics, techniques and procedures (TTPs). This variance in observed ransomware TTPs presents a notable challenge for organizations working to maintain network security and protect against a ransomware threat.

The Cybersecurity and Infrastructure Security Agency (CISA), Federal Bureau of Investigation (FBI), Multi-State Information Sharing and Analysis Center and the following international partners, hereafter referred to as authoring organizations, are releasing this <u>Cybersecurity Advisory (CSA)</u> detailing observed activity in LockBit ransomware incidents and providing recommended mitigations to enable network defenders to proactively improve their organization's defenses against this ransomware operation.

- Australian Cyber Security Centre (ACSC)
- · Canadian Centre for Cyber Security (CCCS)
- United Kingdom's National Cyber Security Centre (NCSC-UK)
- National Cybersecurity Agency of France (ANSSI)
- Germany's Federal Office for Information Security (BSI)
- New Zealand's Computer Emergency Response Team (CERT NZ) and National Cyber Security Centre (NCSC NZ)

The authoring organizations encourage the implementation of the recommendations found in the <u>CSA</u> to reduce the likelihood and impact of future ransomware incidents.

CISA is a U.S. federal agency, an operational component under the Department of Homeland Security.
